The New England Foundation for the Arts envisions a nation where artists flourish and communities celebrate art as essential to a thriving, equitable society. We invest in artists and communities and foster equitable access to the arts, enriching the cultural landscape in New England and the nation.

In fiscal year 2024, NEFA:

• Awarded 485 grants to artists and cultural organizations in New England and across the nation, totaling over \$4.7 million, to support new works for dance and theater, performing arts presenters, and public art.

- Celebrated the first anniversary of the re-launched CreativeGround.org, the go-to place to connect to New England's creative economy.
- Emphasized our cultural policy work, strengthening relationships with state arts advocacy organizations, connecting with our legislators, and endorsing values-aligned policies.
- Held the Celebration of Leadership amidst an April nor'easter in Boston, celebrating the six inaugural New England Leaders of Color fellows and fostering new connections.
- Launched a strategic planning process focusing on the next five years of NEFA's programming and services, emphasizing emerging themes of equity and social impact.

HIGHLIGHTS FROM 2024



SUPPORT ADVANCING EQUITY

Historically underserved communities frequently have reported lower arts participation rates than other groups. To address this disparity and understand the dynamics, the National Endowment for the Arts, in partnership with South Arts and in collaboration with the five other U.S. Regional Arts Organizations (RAOs), launched ArtsHERE, a new grant to expand access to arts participation across the nation through capacitybuilding projects and peer-learning to further support organizational goals. The 112 awards were announced in September 2024. "Everyone should be able to live an artful life, and ArtsHERE is an important step in ensuring we are strengthening our nation's arts ecosystem to make this a reality."

CONNECT BUILDING NETWORKS

Launched in 2012 by the U.S. Department of State and NEFA, Center Stage leverages the power of the performing arts to transcend boundaries, encourages people to dynamically engage with cultures other than their own, and delivers lasting impacts in the U.S. and abroad. Despite residual complications to the presenting field due to the COVID-19 pandemic, 63 artists in nine music, dance, and theatre ensembles from five countries toured the U.S. from June to November 2023. They engaged in high quality artistic performances and impressive deep interactions with a range of communities, including youth, diasporic, and Indigenous, across the nation.

STRENGTHEN INVESTING IN CULTURE

The 21st annual Idea Swap, an event for New England-based nonprofit cultural organizations and touring artists to network and share ideas for touring projects, took place in a new venue, the Nashua Center for the Arts, in Nashua, NH. The Idea Swap is the primary way for the sector in New England to network and engage in person and includes informal networking, five-minute presentations of projects available for New England-wide touring, and facilitated small groups to discuss project ideas, including those that may qualify for funding from NEFA's programs. Pre- and post-event conversation and networking takes place on a digital platform, offering additional opportunities to build connections.




Today, NEFA's programs are regional, national, and international in scope, supporting artists and communities through grants and other resources including workshops, convenings, research, and online tools.
